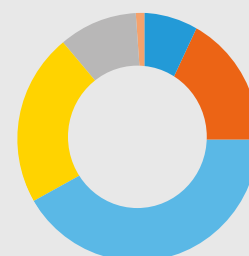

Matching investors and technology suppliers from developed and developing countries

PROCUREMENT 

UNIDO procures goods and services from the business sector (commercial relationship)
